In compliance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "LODR Regulations") and pursuant to the provisions of Sections 108 and 110 of the Act read with the rules framed thereunder and the MCA Circulars, the manner of voting on the proposed resolution is restricted only to e-voting i.e., by casting votes electronically instead of submitting postal ballot forms. Accordingly, the postal ballot notice and instructions for e-voting are being sent only through electronic mode to those Members whose email address is registered with the Company / depository participant(s). The details of the procedure to cast the vote forms part of the 'Notes' to this Notice.



The Board of Directors of the Company has appointed M/s. Sharma and Trivedi LLP (LLPIN: AAW-6850), Practicing Company Secretaries, Mumbai as the scrutinizer (“Scrutinizer”) for conducting the Postal Ballot / e-voting process in a fair and transparent manner.

Pursuant to Section 161 of the Companies Act, 2013, the Board at its meeting held on April 27, 2023, appointed Mr. Rahul Mehta (DIN: 00404552) as an Additional Director (Non-Executive and Independent) of the Company with effect from April 27, 2023, for a period of 5 (Five) Consecutive financial years till April 26, 2028, on the recommendation of the Nomination and Remuneration Committee, subject to the approval of the members by way of special resolution.

Mr. Rahul Mehta has given a declaration to the Board that he meets the criteria of independence as provided in Section 149(6) of the Companies Act, 2013 and Regulation 16 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The Company has also received his consent in writing to act as Director, intimation that he is not disqualified under Section 164(2) of the Companies Act, 2013 and a declaration to the effect that he is not debarred from holding the office of Director pursuant to any Order issued by the Securities and Exchange Board of India (SEBI).

The resolution seeks the approval of members for the appointment of Mr. Rahul Mehta as an Independent Director of the Company for a period of 5 (Five) Consecutive financial years till April 26, 2028, pursuant to Sections 149, 152 and other applicable provisions, if any, of the Act and the Rules made thereunder (including any statutory modification(s) or re-enactment(s) thereof) and he shall not be liable to retire by rotation.
